ORDER

23.3.18

- 1. The petitioner Shri Dulal Bora is present. The public authority is represented by Shri Nirajan Bora, Under Secretary and SPIO of Chief Minister's Secretariat (CMS), Assam accompanied by Shri Probal Jyoti Medhi, Sr. Administrative Assistant of CMS. The second appeal petition dated 3.7.17 is taken up for hearing in presence of both the parties.
- 2. The SPIO and Under Secretary of CMS has submitted a written statement dated 21.3.18 stating that the petitioner shri Dulal Bora filed a complaint petition dated 24.5.16 against (1) Smti. Runumi Gogoi, Chairman of Rajyik Sishu Suraksha Ayog, (2) Smti. Leena Das, Secretary of the Ayog, and (3) Shri Paresh Kalita, supplier/ contractor associated with the Ayog. The complaint petition was transferred by the CMS to Private Secretary to the Minister, Social Welfare Department vide letter No. CMO.04/2016/182 dated 7.6.16. Subsequently, the petitioner Shri Dulal Bora filed an RTI petition dated 13.8.16 wanting to know, inter alia, action taken on his complaint petition dated 24.5.2016. The SPIO of CMS has stated in his WS that the RTI petition has meanwhile been transferred to the SPIO of Social Welfare Department vide letter No. CMS.7/2016(RTI)/Pt. V/668 dated 16.03.2018.
- 3 From the above it appears that the onus to furnish the sought for information now lies with the SPIO of Social Welfare Department. He is, therefore, directed to furnish the sought for information to the petitioner within 30 days from the date of receipt of the RTI petition transferred to him by the CMS.

With the above order, the second appeal petition is disposed of.
