## <u>O R D E R</u>

23.3.18

- 1. The petitioner Shri Dulal Bora is present. The public authority is represented by Shri Nirajan Bora, Under Secretary and SPIO of Chief Minister's Secretariat (CMS), Assam accompanied by Shri Probal Jyoti Medhi, Sr. Administrative Assistant of CMS. The second appeal petition dated 3.7.17 is taken up for hearing in presence of both the parties.
- 2. The SPIO and Under Secretary of CMS has submitted a written statement dated 21.3.18 stating that the petitioner Shri Dulal Bora filed a complaint petition No. D.B.292/4/15 dated 5.12.15. The complaint petition was forwarded by the CMS to the Secretary, Personnel Department, Govt. of Assam vide letter No. CMS.111/2015/Pt/26 dated 19.1.16. Subsequently, the petitioner Shri Dulal Bora filed an RTI petition dated 13.8.16 wanting to know about the action taken on his complaint petition dated 5.12.15. The SPIO of CMS has stated in his WS that the RTI petition has meanwhile been transferred to the SPIO of Personnel Department, Govt. of Assam vide letter No. CMS.7/2016(RTI)/Pt.V/667 dated 16.03.2018.
- 3 From the above it appears that the owners of furnishing the sought for information now lies with the SPIO of Personnel Department, Govt. of Assam. He is, therefore, directed to furnish the sought for information to the petitioner within 30 days from the date of receipt of the RTI petition transferred to him by the CMS

With the above order, the second appeal petition is disposed of.
