## <u>O R D E R</u>

12.3.18

- 1. The petitioner Shri Dulal Bora is present. The public authority is represented by Shri Nirajan Bora, Under secretary and SPIO of Chief Minister's Secretariat (CMS), Assam accompanied by Shri Probal Jyoti Medhi, Sr. Administrative Assistant of CMS. The second appeal petition dated 3.7.17 with reference to RTI petition dated 13.8.16 submitted before the SPIO of Chief Minister's Secretariat is taken up for hearing in presence of both the parties.
- 2. The concerned SPIO of CMS has submitted a written statement dated 12.3.2018 stating that originally the petitioner Shri Dulal Bora submitted a complaint petition dated 16.11.15 before the Hon'ble Chief Minister of Assam against Dr. Mrinal Barman of Animal Husbandry & Veterinary Department. It was forwarded to the Addl. Chief Secretary, Animal Husbandry & Veterinary Department, Govt. of Assam for necessary action vide UO No. CMO.04/2015/4632 dated 30.11.2015. On 28.2.2018, the RTI petition dated 13.8.16 was also transferred to the SPIO of Animal Husbandry & Veterinary Department, Govt. of Assam. It appears that there has been delay on the part of both the parties in filing the first appeal petition by the petitioner and in transferring the RTI petition by the SPIO.
- 3. In view of the above, the SPIO of Animal Husbandry & Veterinary Department, Govt. of Assam is directed to furnish the information sought for by the petitioner vide his RTI petition dated 13.8.16 within 30 days from the date of receipt of this order..

With the above order, the second appeal petition dated 3.7.17 is disposed of.
