The Petitioner Sri Durgeswar Das is present. The Public Authority to be represented by the SPIO, office of the CDPO, Pachim Kaliabor ICDS Project is absent without any information nor had he made any written submission in compliance to this Commission's order dt. 9-1-2018 asking him to show cause as to why penalty under Sec. 20(1) of the RTI Act, 2005 shall not be imposed upon him for his failure to furnish the information sought for by the Petitioner.

The Petitioner Sri Durgeswar Das stated that he had not received any information from the SPIO/CDPO, Pachim Kaliabor ICDS Project nor could he inspect the document in the office of the SPIO/CDPO as during his visit to the office as he was informed that the CDPO was engaged in NRC duties.

The SPIO/CDPO, Pachim Kaliabor ICDS Project has not furnished any information till date and has not complied to the order of the Commission dt. 9-1-2018. The SPIO/CDPO is given last opportunity to reply to the show cause issued of order dt. 9-1-2018. The written reply indicating clearly date of receipt of the RTI petition, reason for failure in attending the hearing and the date of furnishing record for inspection to the applicant, shall be submitted to the Commission at the time of hearing when the CDPO/SPIO shall be heard in person before the passing of any order to that effect.

The Commission will review the matter again **on 27-4-2018 at 12.30 P.M.**
