1, The petitioner Sri Anil Kr.Baruah is absent. The Deputy Secretary, (Estt) of PWD (Building and NH) Department Sri Utpal Goswami and Deputy Secretary and SPIO of Health & F.W Department Sri A.S.A Barbhuya are present to represent PWD and Health Department respectively.

2. The second appeal petition dated 9-5-2017 is taken up for further consideration, in pursuance of this Commission's earlier orders , the last one being dated 5-3-2018.

3. The Deputy Secretary, PWD Sri Utpal Goswami submitted orally that an amount of Rs. 10,63,435/- has been released to the Executive Engineer, PWD (Building), Dibrugarh to make payment for up-gradation work of Panitola PHC to CHC. He also furnished a copy of the fixation of ceiling communication to substantiate his oral submission.

4. The Secretary, Health & F.W. Department submitted a prayer dated 2nd April, 2018 praying for three weeks time to appear before this Commission on the ground that they are pre-occupied with Assembly matters and financial year ending. Time as prayed for is granted.

Choudhury, ACS and (iii) SPIO of the Health & F.W Department are directed to appear on the next date of hearing and file an affidavit stating the latest position in the matter after consultation with P.W.D (NH & Building) Department, Govt. of Assam.*

6. *Commissioner & Secretary, PWD is also directed to authorize the Departmental SPIO or Mr.Utpal Goswami , Deputy Secretary (Building and N.H) to be present on the next date of hearing when final orders are likely to be passed.*

7. *Also issue notice to the petitioner Sri Anil Kr. Baruah to be present on the next date of hearing and confirm whether he has since received the pending payment.*

8. *Fix 3rd May, 2018, 1.00 P.M for the next date of hearing*
