**O R D E R**  
**04.04.2018**

1. The petitioner Sri Dulal Bora as well as the public authority represented by Sri Niranjan Bora, Under Secretary and SPIO of Chief Minister's Secretariat, accompanied by Sri Prabal Jyoti Medhi Sr. Administrative Assistant are present.

2. The second appeal petition dated 03-7--2017 is taken up for hearing in presence of both the parties.

3. The SPIO and Under Secretary of Chief Minister's Secretariat has submitted a written statement dated 4-4-2018 . In his written statement he has stated that the petitioner originally filed a complaint petition dated 21-11-2015 against one Sri Probin Bora, a college teacher, before the Additional Chief Secretary in the C.M Secretariat regarding his educational qualification and eligibility for his appointment as college teacher as per UGC norms. It is stated in the W/S that the complaint petition was forwarded to the Principal Secretary, Govt. of Assam, Education Department vide letter No. CMS.111/2015/230 dated 5-7-2016.

4. Subsequently, the petitioner filed an RTI petition dated 13-8-2016 seeking the following informations :-

- (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 21-11-2015 and name of the Inquiry Officer with his designation ;
- (b) names and addresses of the persons mentioned in the complaint petition dated 21-11-2015, and

(c) photo copy of inquiry report submitted by the Inquiry Officer to his higher authorities.

5. It is mentioned in the W/S of the SPIO of C. M. Secretariat that the RTI petition was also transferred to the SPIO of Education, (Secondary) Department vide letter No. CMS.7/2016 (RTI)/Pt.V/659 dated 14-3-2018.

7. The SPIO of Secondary Education Department is ,therefore, directed to furnish the sought for information to the petitioner within 30 days from the date of receipt of the transferred RTI petition.

8. With the above order the second appeal petition dated 3-7-2017 is disposed of.

9. Since this second appeal petition is identical with second appeal case No.KP(M).1194/2017, they are clubbed together and both the cases are treated as disposed of with the further direction to the SPIO of Secondary Education Department that a common reply to both the 2<sup>nd</sup> appeal cases will suffice.
