O R D E R 11.04.2018

- 1. The petitioner Sri Dulal Bora is present. The public authority is represented by (1) Sri Naren Ch. Basumatary, ACS, Joint Secretary and SPIO of Home and Political Department, (2) Sri Sourov Mitra, Sr. Administrative Assistant of Home (A) Department and (3) ASI Sri Paresh Borah, Assam Police Headquarters, Ulubari, Guwahati.
- 2. The second appeal petition dated 24-7-2017 is taken up for hearing in presence of both the parties.
- 3. The petitioner Sri Dulal Bora has submitted a written statement dated 11-4-2018 stating that he has meanwhile received the information sought for vide his RTI petition dated 30-7-2016 which was addressed to the PIO of the office of Chief Secretary.
