O R D E R
05.04.2018

1. The petitioner Sri Dulal Bora is present. The public authority represented by the Under Secretary and SPIO of C.M's Secretariat accompanied by Sri Prabal Jyoti Medhi, Sr. Administrative Assistant of C.M's Secretariat is also present.

2. The second appeal petition dated 3-7-2017 is taken up for hearing in presence of both the parties.

3. The SPIO of Chief Minister's Secretariat has submitted a written statement dated 5-4-2018 stating that the petitioner Sri Dulal Bora submitted a complaint petition dated 30-11-2015 before the then Chief Minister of Assam, complaining that Sri Pabitra Baishya, the then District Transport Officer of Darrang District did not have the requisite technical qualifications. It has been stated in the W/S that the complaint petition was forwarded to the Additional Chief Secretary, Transport Department, vide U/O No. CMO.04//2015/4717 dated 8-12-2015. The petitioner followed up the complaint petition by filing an RTI petition dated 13-8-2016 filed before the PIO of Chief Minister's Secretariat seeking the following informations :-

- a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 30-11-2015 and name of the Inquiry Officer with his designation ;
- b) names and addresses of the persons mentioned in the complaint petition dated 30-11-2015, and
- c) photo copy of inquiry report submitted by the Inquiry Officer to his higher authorities.

4. The SPIO of Chief Minister's Secretariat has stated that the RTI petition was also transferred to the SPIO of Transport Department vide letter No. CMS.7/2016(RTI)/Pt-V/677 dated 3-4-2018
5. The RTI petition was followed up by first appeal petition dated 22-5-2017 and second appeal petition dated 3-7-2017.
6. The petitioner submitted orally that he has not received any information from the SPIO of Transport Department so far.
7. This Commission, therefore, directs the SPIO of Transport Department to furnish the sought for informations to the petitioner in respect of (a) and (c) of para-3 above within 30 days from the date of receipt of this order.
8. Since the name of person complained against is already mentioned in the complaint petition, no reply to point No. (b) of para-3 above is considered necessary.
9. With the above order the second appeal petition dated 3-7-2017 is disposed of.
