**O R D E R**  
**05.03.2018**

1. The public authority represented by Sri Niranjan Bora, Under Secretary and SPIO of Chief Minister, Assam Secretariat is present. He is accompanied by Sri Prabal Jyoti Medhi, Sr. Administrative Assistant in the said Secretariat.
2. The petitioner Sri Dulal Bora is absent. He has sent an e-mail dated today the 5<sup>th</sup> March, 2018 requesting for postponement of the date of hearing.
3. The SPIO and Under Secretary of Chief Minister's Secretariat has submitted a written statement dated 3<sup>rd</sup> March, 2018 stating that the petitioner's RTI petition dated 17-8-2016 was transferred to the SPIO of Finance Department vide CMO's letter dated 8<sup>th</sup> February, 2016, bsince the subject matter of the RTI petition relates ....to Finance Department.
4. The SPIO of Chief Minister's office have, however, did not enclose the original complaint petition dated 30-1-2016 addressed to the Additional Chief Secretary in Chief Minister's office, which is the basis of the RTI petition dated 17-8-2016. It is also seen that while the SPIO of Chief Minister's Sectt. transferred the RTI petition much after the lapse of the time period specified in the RTI Act, 2005, the petitioner also filed his first appeal petition much after the lapse of the stipulated time period.
5. It is also seen from the W/S of the SPIO of Chief Minister's office and its enclosures that the original complaint petition dated 13-2-2016 of the petitioner was already forwarded to the SPIO of Finance Department vide U/O No. CMS.7/2016(RTI/Pt.VII/683 dated 02-8-2017.
6. In view of the above, the SPIO of Finance Department is directed to inform the petitioner within 30 days from the date of receipt of this order :-

(a) Whether any inquiry has been ordered or any action has been taken on the petitioner's original complaint petition dated 17-8-2016 and if so , the number

of the file from which inquiry has been ordered/ action has been taken , the name of the inquiry officer and the present designation ,

(b) Copy of the inquiry report or narration of the action taken on the complaint petition ;

7. Furnishing the names of the persons complained against vide complaint petition dated 17-8-2016 is found to be redundant as they are mentioned by the petitioner himself in his complaint petition.

8 In view of the above order, re-fixation of the date of hearing as prayed for by the petitioner, does not appear to be necessary and the second appeal petition dated 27-6-2017 is disposed of.
