O R D E R 23.03.2018

Shri A.S. Abdullah Barbhuyan, Deputy Secretary to the Government of Assam/SPIO, Health & Family Welfare Department is present. He has submitted a Written Statement dated 22.03.2018.

A Written Statement dated 20.03.2018 has been received from the Chief Secretary's office, Dispur.

The Appellant, Shri Dulal Bora is present.

Perused the Written Statement received from the Chief Secretary's office. It has been submitted that the Application for information dated 09.08.2016 as well as the First Appeal dated 16.05.2017 had been transferred to the Health & Family Welfare Department under intimation to the Appellant.

Heard the parties and perused the Written Statement of the SPIO. It is seen that the information had been furnished through a letter dated 20.09.2016. The Appellant submitted that he had received the said information, although months after the stated date. He had sought information on action taken on a representation he had submitted earlier and was not satisfied with the action taken. The SPIO submitted that there was no departmental inquiry on the allegations of irregularities in recruitment brought up by the Appellant and that the Vigilance Department conveyed the approval for closing the Preliminary Inquiry initiated against the person mentioned by the Appellant. The Appellant agreed that it is now a matter of grievance as to why a thorough inquiry was not made to determine facts on his allegations.

In view of the facts brought out above, the Commission hereby concludes that the information sought for has indeed been provided to the Appellant and the dissatisfaction of the Appellant is infact a grievance at lack of proper action on the representation he had made on certain irregularities committed by certain official in the matter of recruitment. The Commission therefore decided to dispose of the Second Appeal.
