The Appellant, Shri Durgeswar Das is present.

The SPIO absent.

A Written Statement dated 14.02.2018 has been received from the PIO, office of the First Appellate Authority/Deputy Commissioner, Nagaon.

Perused the Written Statement. It has been submitted that the First Appeal dated 10.08.2017 was heard on 10.10.2017 and an order issued directing the Circle Officer, Raha Revenue Circle to furnish the information within 7 days.

Heard the Appellant. He submitted that he has not received the information he had sought for. He added that the Circle Officer has not furnished the information to him inspite to the order of FAA on his First Appeal. However, he had received a copy of a letter written by the Circle Officer to the Addl. Deputy Commissioner, Land Acquisition Branch, Nagaon bearing no. RC30/2009/889 dated 03.07.2017 to transfer the Application for information.

Perused the aforesaid letter from the Circle Officer as produced by the Appellant. It is seen that the Circle Officer had transferred the Application for information without giving justification for transferring the same. It is apparent from the order of the FAA that the information was to be furnished by the Circle Officer and not the DC's office.

In view of the facts brought out above, the Commission hereby orders that the SPIO, office of the Circle Officer, Raha Revenue Circle shall furnish the information to the Appellant, free of cost, within 15 days of receiving of this order.

The Second Appeal is hereby disposed of. However, the Appellant shall be at liberty to move this Commission, if he is aggrieved with the response of the SPIO.
