Shri Sujit Das, Gram Sevak/Assistant SPIO, Mahamaya Dev. Block, Dhubri is present.

The Appellant, Shri Sohid Ali is present.

A Written Statement dated 12.02.2018 has been received from the Addl. Deputy Commissioner/SPIO, office of the Deputy Commissioner, Dhubri.

Perused the Written Statement. It has been submitted that the First Appeal dated 06.03.2017 had been transferred to the Block Dev. Officer, Mahamaya Dev. Block, Dhubri through a letter dated 10.03.2017.

Heard the Appellant. He submitted that he had not received the information he had sought for through his Application for information dated 20.01.2017.

Heard the ASPIO. He submitted that the Appellant had been requested to visit the office for inspection of records and that after perusing the documents furnished to him, the latter (the Appellant) refused to receive the same.

The Appellant further submitted that he had refused to receive the said documents as they were not wholly relevant to the information he had sought for.

The ASPIO submitted that he had in his possession the information/documents collected and the same could be handed over to the Appellant if he so desired. After perusing the documents during the hearing the Appellant agreed to receive the same stating that some information/documents were still wanting. He acknowledged receipt of the information after recording the wanting information on the letter forwarding the information.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall provide the remaining information to the Appellant, free of cost, within 10 days of receiving this order.

The Second Appeal is hereby disposed of.
