Shri A.K. Chetia, Special Consultant/SPIO, National Health Mission, Assam, Smt. Niharika Baishya, HR Executive, Smt. Mili Roy, Data Manager, SHQ and Shri Dhrubajyoti Sarma, Administrative Assistant are present. A Written Statement dated 17.02.2018 submitted by the SPIO.

The Appellant/Complainant absent without information.

After perusing the Complaint of Non-Compliance of the Commission's order and the Written Statement of the SPIO and hearing personal depositions of the SPIO and his colleagues, it is seen that the Appellant is not fully satisfied with the information that had been furnished to him in response to his Application and the order of the Commission as regards the copies of the online application of the specified candidates and the headwise (componentwise) marks obtained by the selected candidates. The SPIO's explanation that these two items of information could not be provided on account of the fact that the same is not available in the form and in manner in which he has sought.

In view of the submission by the Respondents, the Commission hereby orders that the SPIO shall review the representation of the Appellant/Complainant and the records of the Public Authority and take necessary action either to provide the documents containing the information sought for, free of cost, or explain clearly why the information sought for was not available in the format in which it has been sought. The response shall be provided to the Appellant/Complainant within 10 days of receipt of this order.

The Complaint of Non-Compliance is hereby disposed of.
