**O R D E R**

The petitioner Shri Joydeb Das is present. The public authority is represented by:- (1) Shri Saifun Noor Ahmed, SPIO and DGM (Law) in the office of the Managing Director of APDCL and (2) Shri Biman Baruah, AGM (Law) of the same office. The second appeal petition dated 19.1.18 with reference to RTI petition dated 16.10.17 is taken up for hearing in presence of both the parties.

The petitioner stated by way of written submission that he has since received all the informations from the DGM (LRE) and SPIO of the office of the CGM (PP&D), APDCL, sought for vide his RTI petition dated 16.10.17 except the information mentioned at para 1(c) of the RTI petition namely copies of NIT, newspaper advertisement, work order and comparative statement. The SPIO of APDCL stated that the RTI petition dated 16.10.17 was transferred to the SPIO and DGM (LRE) in the office of the CGM, APDCL. He further stated that the NIT is a voluminous document and the petitioner was requested to deposit the cost thereof. The petitioner submitted orally that he received the said communication and is willing to pay the required cost after inspection of the relevant records.

The SPIO and DGM (LRE) in the office of the CGM (PP&D) being the holder of information is, therefore, directed to allow the petitioner to inspect the relevant records in respect of para 1(c) with reference to his RTI petition dated 16.10.17 during office hours on any working day within 30 days from the date of receipt of this order and also allow the petitioner to take photocopies of documents sought for by him free of cost upto 20 pages and thereafter on payment of Rs. 2.00 for every additional page of photocopy.

With the above order the second appeal petition dated 19.1.18 is disposed of.
