ORDER 19.04.2018

- 1.. The petitioner Sri Joydeb Das is present. The public authority i.e., Assam Seeds Corporation Ltd is represented by its General Manager, (F&P) and SPIO Sri Pradip Buragohain, accompanied by Sri Gunjanan W. Shyam, ASPIO.
- 2. The second appeal petition dated 19-1-2018 is taken up for hearing in presence of both the parties.
- 3. From perusal of the case records it is seen that the petitioner Sri Joydeb Das filed an RTI petition dated 12-10-2017 before the PIO of Assam Seeds Corporation Ltd. requesting for compliance report in respect of this Commission's order No. KP(M).246/2017 dated 28-6-2017.
- 4. Not getting any response to the appeal petition he filed a first appeal petition dted 7-12-2017 before the First Appellate Authority of Assam Seeds Corporation Ltd. followed by second appeal petition dated 19-1-2018 before this Commission.
- 5. The SPIO of ASCL submitted before this Commission a communication dated 9-3-2018 from M.D, ASCL addressed to the CIC, Assam Information Commission stating the actions taken by him. But he has referred to this Commission's order in second appeal case No. KP(M).621/2016 and not to second appeal case No. KP(M)246/2017. In course of today's hearing it transpired that ASCL have partially complied with this Commission's order at paragraph-5 dated 28-6-2017 in second appeal case No.KP(M) 246/2017
- 6. The SPIO of ASCL is directed to submit a written affidavit on or before the next date of hearing giving the factual position in respect of compliance of the said order.

- 7. As regards paragraph 6 & 7 of the order dated 28-6-2017 mentioned above, the SPIO is directed to transfer this portion to SPIO of the office of Chief Secretary, Govt. of Assam for furnishing compliance report to this Commission within 30 days thereafter.
- 8; Fix May 14, 2018, 1.00 P.M for review of compliance.
