- 1.. The petitioner Sri Joydeb Das is present. The public authority to be represented by the SPIO of the office of APDCL, Bijulee Bhawan, Paltan Bazar, Guwahati -8 is absent without any information.
2. The second appeal petition dated 19-1-2018 is taken up for hearing ex-parte in the absence of the public authority.

It is seen from the case records that vide their letter dated 3-1-2018 the Deputy General Manager, (NRE) and PIO of the office of Chief General Manager, (PP&D) of APDCL furnished reply to the petitioner Sri Joydeb Das in response to his RTI petition dated 16-10-2017.
