- 1.. The petitioner Sri Joydeb Das is present. The public authority to be represented by the SPIO of the office of District Agriculture Officer, Barpeta is absent without any information.
2. The petitioner submitted that in response to his RTI petition dated 12-10-2017 he has received the required information from the Sub Divisional Agriculture Officer, Pathsala on 28-11-2017 after paying the cost thereof. From this it appears that the SPIO of District Agriculture Officer, Barpeta transferred the RTI petition to the Sub Divisional Agriculture Officers under his jurisdiction. The petitioner submitted that he has not received any information from the SPIO of the District Agriculture Officer, Barpeta or any other SDAOs' of the District.
3. Since the sought for information appears to be voluminous, the SPIO of the office of the DAO of Barpeta is directed to obtain the relevant records relating to the sought for information from the defaulting SDAOs' under him and allow the petitioner to inspect the same during office hours on any working day within 15 days from the date of receipt of this order and allow the petitioner to take photo copies thereof , free of cost, up to 50 copies against each SDAO and thereafter on payment of Rs. 2/- for every additional page of photo copy.
- 4.. With the above order the second appeal petition is disposed of.
