**O R D E R**  
**07.05.2018**

1. The petitioner Sri Dulal Bora is present. The public authority is represented by Sri Niranjan Bora, SPIO and Under Secretary of Chief Minister's Sectt accompanied by Sr.Administrative Assistant of Chief Minister's Sectt. Sri Prabal Jyoti Medhi.

2. The second appeal petition dated 3-7-2017 read with RTI petition dated 13-8-2016 is taken up for hearing in presence of both the parties.

3. From perusal of the case records it is seen that the petitioner Sri Dulal Bora filed a complaint petition dated 24-5-2016 before the Chief Minister, Assam. In his complaint petition he leveled several allegations against the then APSC Member Dr. Samedur Rehman. Subsequently he filed RTI petition dated 13-8-2016 before the PIO of the office of Chief Minister, seeking the following informations:-

- (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 24-5-2016 and name of the Inquiry Officer with his designation ;
- (b) names and addresses of the persons mentioned in the complaint petition dated 24-5-2016, and
- (c) photo copy of inquiry report submitted by the Inquiry Officer to his higher authorities.

4. The Under Secretary and SPIO of Chief Minister's office submitted a written statement dated 7<sup>th</sup> May, 2018 stating that the petitioner's original complaint petition dated 24-5-2016 was forwarded to the Principal Secretary to the Government of Assam, Personnel Department and to the Principal Secretary, Govt. of Assam, Higher Education Department, vide U/O No. CMO.4/2016/1511 dated 19-7-2016

5. Subsequently the RTI petition dated 13-8-2016 was also transferred to the SPIOs' of Personnel and Higher Education Departments, Govt. of Assam vide letter dated 4<sup>th</sup> May, 2018.

6. In view of the above, the SPIOs' of Personnel Department and Higher Education Department, Govt. of Assam are directed to furnish the sought for informations against point No. 3 (a) and (c) above within 30 days from the date of receipt of this order.

7. As against para 3 (b) above, the names of persons complained against are already mentioned in the complaint petition.

8. Put up again on 12-6-2018 12.30 P.M for review of compliance by the concerned SPIOs.
