## ORDER 20.04.2018

- 1.. The appellant Sri Jyoti Prakash Ghosh is present. (i) Sri Virendra Mittal, IAS, Deputy Commissioner, Kamrup (Metro) (ii)his predecessor Dr. M. Angamuthu,IAS, presently Commissioner & Secretary, GDD Department, (iii) Sri Prasanta Protim Kathkotia, ACS, SPIO and Additional Deputy Commissioner, Kamrup (Metro) District and (iv) Dr. Dhurba Jyoti Hazarika, ACS. Circle Officer, Dispur Revenue Circle are also present.
- 2. The second appeal petition dated 12-5-2016 filed by Sri J. P. Ghosh is taken up for further hearing in pursuance of this Commission's earlier orders, the last one being dated 2-4-2018.
- 3. The Deputy Commissioner, Kamrup (Metro) and SPIO of D.C's office deposed that the mutation case record M/C No. 26/2010-11, copy of which was sought for by the petitioner vide his RTI petition dated 24-9-2015, has been found in the office of the Deputy Commissioner after a thorough search of the voluminous records. The Deputy Commissioner and the SPIO further informed this Commission that as regards the existing discrepancy between the land records maintained centrally in the RKG branch of Deputy Commissioner's office and the records maintained in the Circle Office of Dispur Revenue Circle, an inquiry has been ordered by the D.C at the level of Additional Deputy Commissioner. The Deputy Commissioner Kamrup (Metro) prayed for three weeks' time to furnish information about the outcome of the inquiry.
- 4. In view of the above, this Commission passes the following orders :-
  - (a) The SPIO of Deputy Commissioner's office is directed to furnish a copy of the mutation case No. 26/2010 along with complete case records to the petitioner, free of cost, within seven (7) days from the date of this order, which was pronounced in presence of both the parties.

- (b) Time as prayed for by the Deputy Commissioner, Kamrup (Metro) is granted to apprise this Commission about the outcome of the inquiry ordered by him into the discrepancies between the relevant land records being maintained in the RKG branch of his office and in the Dispur Revenue Circle.
- 5. The appellant Sri J. P. Ghosh furnished a copy of a reply dated 9-8-2016 furnished by Panbazar Police Station, Guwahati to another RTI petition dated 1<sup>st</sup> August, 2016 which was filed by Sri Ghosh before the O.C, Panbazar Police Station, Guwahati. Copy of his RTI petition enclosing the Panbazar Police Station reply dated 9-8-2016 is entered into the case records. From the police report it appears that the sale deed purportedly executed by the petitioner's wife Smti Manju Ghosh in favour of one Sri Sukomol Sinha might have been based on impersonation and forgery.
- 6. Fix <u>14-5-2018</u>, <u>1.30 P.M</u> for review of compliance by SPIO of the office of the D.C., Kamrup (Metro) of direction as at 4 (a) and 4(b) above.
