## O R D E R 04.05.2018

- 1. The petitioner/appellant Sri Utpal Das is present. The public authority to be represented by the Sr. Sub Registrar, Kamrup (Metro) District is absent.
- 2. The second appeal petition dated 4-9-2017 is taken up for further consideration in pursuance of this Commission's earlier orders, the last one being dated 10-4-2018, wherein, the Sr. Sub Registrar, Kamrup (Metro) was directed to give a copy of the sale deed No. 5031/2003 to the petitioner within 15 days from the date of receipt of the order.
- 3. The Sr. Sub Registrar has sent a written submission dated 4-5-2018 which is entered into the case records. In his W/S he has stated that a sale deed bearing Sl. No. 7939, deed No. 5031 dated 5-6-2003 was duly registered in his office as per record of the Fee Book, relevant page of which was enclosed with the written statement. The written statement goes on to mention that the scanned copy of the above mentioned sale deed was not found in the computerized office record as it might have been kept un-scanned at the time of digitization by the Company named M/S Web com (India) Pvt. Ltd.
- 4. The Sr. Sub Registrar by his W/S has prayed for additional time of 15 days to search out the original copy of the above mentioned sale deed, for which he has deputed necessary staff.
- 5. Time as prayed for is granted, and fix <u>22-5-2018, 1.00 P.M</u> for next hearing.

6. Copy of the written statement dated 4-5-2018 submitted by the Sr. Sub Registrar, Kamrup (M) District was marked to the petitioner Sri Utpal Das also. But the petitioner submitted that he has not received his copy. He prayed for a copy of the w/s with its enclosure. His prayer was granted and a copy of the w/s with its enclosure is ordered to be furnished to him.
