**ORDER**  
**11-04-2018**

The petitioner Sri Zarjish Ahmed Laskar is absent without any intimation. The public authority is represented by Sri Jyotish Das, Joint Director i/c cum-SPIO, Food, Civil Supplies & Consumer Affairs, Assam assisted by Sri Dhiraj Baisya, Jr. Asstt. The Joint Director i/c cum-SPIO, Food, Civil Supplies & Consumer Affairs, Assam has informed the Commission vide letter dt. 27<sup>th</sup> March, 2018 that the 1<sup>st</sup> Appeal petition dt. 3-10-2017 filed by Sri Zarjish Ahmed Laskar relates to the office of the Deputy Commissioner, Food & Civil Supplies and Consumer Affairs, Hailakandi.
