ORDER 18-04-2018

The petitioner Sri Durgeswar Das is present. The public authority to be represented by the CDPO, Lumding ICDS Project is absent without any intimation. No record of receipt of notice by the public authority could be produced by the diarist. In the absence of postal receipt it could not be ascertained as to whether the Commission's order dt. 3-3-2018 was received by the SPIO, office of the CDPO, Lumding ICDS Project. It is seen that the copy of the same notice was received by the petitioner who is present. Considering that the petitioner is present, the matter is taken up for hearing ex-parte.

On perusal of the RTI petition dt. 4-5-2017 filed by Sri Durgeswar Das before the SPIO, O/o the CDPO, Lumding ICDS Project, it appears that the petitioner had sought for information on detail of fund utilized by the Angan Wadi Centres, along with other detail for the period 2013-14 to 2015-16, as noted therein. Due to non-receipt of information from the public authority, he filed his 1st Appeal before the CDPO, Lumding ICDS Project on 12-6-2017, but no hearing was fixed by the CDPO, Lumding ICDS Project.

The Commission therefore directs the SPIO & the CDPO, to furnish the information to the petitioner, within 20 days from the date of receipt of this order, with intimation to the Commission. If for any reason, the SPIO is unable to comply with the order, he will make a written submission to this effect, stating reasons thereof before the Commission, within 20 days from the date of receipt of this order.

With the above direction the 2nd Appeal petition dt. 24-8-2017 is disposed of.
