Both the parties are absent. The B.D.O. Batadraba Development Block vide letter dated 20-4-2018 has informed the Commission that the petitioner Sri Durgeswar Das has filed 2 nos. of RTI petitions concerning Batadraba and Kadamoni Gaon Panchayats, under Batadraba Development Block registered in Case No. SIC.NGN.221/2017 and SIC.NGN.222/2017. He stated that the records of RTI petition could not be traced, as no copies for reference were attached with the letter received from the office of the Joint Registrar of the Commission. The Secretary of both the Gaon Panchayats were informed to reply to the cases on or before the date of hearing. He also stated that all the Gaon Panchayat Secretaries and most of the Block staffs were fully engaged in NRC duty for which official work were getting delayed and as NRC hearing is going on, personal attendance may not be possible.

In view of the circumstances stated above, the Commission directs the Secretary, Batadraba and Secretary, Kadamoni Gaon Panchayats and the B.D.O. Batadraba Development Block to furnish the information to the petitioner within 21 days from the date of receipt of this order, with intimation to the Commission. If for any reason, they are unable to comply with the order, they will make a written submission, stating reasons thereof before the Commission, within 21 days from the date of receipt of this order.

With the above direction, the 2nd Appeal petition dt. 12-10-2017 of both the cases are disposed of. Keep a copy of this order in both the files for record.
