The petitioner Smt. Rebati Saikia is absent without any intimation. The public authority is represented by Sri Golak Ch. Deka, Dy. S.P. assisted by ASI/CIK Sri Paresh Bora, AP. Hqrs., Ulubari.

The Assistant General of Police (A) & SPIO has informed the Commission that the RTI petition filed by Smt. Rebati Saikia was received by the Headquarter on 1-12-2017 and was forwarded to the concerned branch of the Headquarter to furnish the required information at an early date. The concerned branch i.e. Force 'A' Branch, who maintain the service records in respect of Police personnel of UB stream has submitted the information that the service sheet in respect of UBC Moniram Saikia of Golaghat DEF is maintained by the office of the Supdt. of Police, Golaghat and the required information may be obtained from the said office. The petitioner was informed accordingly vide letter dt. 6-3-2018. The Commission observes that the information sought for is available with the S.P., Golaghat. He is considered as deemed PIO U/S. 5(4) & 5(5) of the RTI Act, 2005. He is directed to furnish the information to the Asstt. General of Police (A) & SPIO within 15 days from the receipt of this order who in turn will furnish the required information to the petitioner within seven days thereafter.

With the above direction the 2nd Appeal petition dt. 12-2-2018 is disposed of.
