**O R D E R  
25- 04-2018**

The petitioner Dulal Bora is absent without any intimation. The public authority is represented by Sri Niranjan Bora, Under Secretary & SPIO, C.M's Secretariat assisted by Sri Prabal Jyoti Medhi, Sr. A. Assistant, C.M's Secretariat.

The 2<sup>nd</sup> Appeal petition dt. 3-7-2017 is taken up for consideration exparte, in the absence of the petitioner. The SPIO, C.M. Secretariat submitted a written statement dt. 25-4-2018 that the RTI petition dt. 13-8-2016 was received on 20-8-2016 seeking for information on the complaint petition dt. 26-9-2015. The said complaint petition was forwarded to the Commissioner & Secretary to the Govt. of Assam, Home & Political Deptt. vide letter dated 30-10-2015 with copy to the applicant. The RTI petition has been transferred to the SPIO, Home Department vide letter dt. 10-4-2018. The SPIO also submitted orally that 445 nos. of RTI petitions were submitted by the petitioner Sri Dulal Bora in the month of August, 2016. Since the RTI petitions received were extraordinarily huge in number, Sri Dulal Bora was informed vide letter dt. 19-9-2016 that information sought for by him, vide his RTI petitions would be provided to him in due course, depending on availability of resources. He furnished a copy of the aforesaid letter dt. 19-9-2016.

On perusal of record, the Commission observes that the petitioner had filed his 2<sup>nd</sup> Appeal dt. 3-7-2017 due to non-receipt of any response to his RTI petition dt. 13-8-2016 and the 1<sup>st</sup> Appeal petition on 22-5-2017. There is nothing on record to show that the 1<sup>st</sup> Appeal petition was heard and responded to, or it was rejected or not admitted on the ground of being time barred. No action seems to have been taken on the 1<sup>st</sup> Appeal petition. Therefore the 2<sup>nd</sup> Appeal petition which was submitted within the time period stipulated U/S. 19(3) of the RTI Act, 2005 is admitted and taken up for consideration.

The RTI petition has been transferred to SPIO, Home Department by the SPIO, C.M. Secretariat. The Commission directs the SPIO, Home Department to furnish the information sought for by the petitioner within 30 days from the date of receipt of this order. If for any reason the public authority is unable to comply with the order, he will make a written submission to this effect, stating reasons thereof, before the Commission within 20 days from the date of receipt of this order.

With the above direction the 2<sup>nd</sup> Appeal petition dt. 3-7-2017 is disposed of.
