## ORDER 17.04.2018

- 1. The petitioner Sri Jyotish Kr. Das is present. No one from Assam Cricket Association was present. It is seen from the records of the Registry of this Commission that copy of this Commission's order dated 14-3-2018 fixing 17-4-2018 for hearing the instant second appeal petition was received by Assam Cricket Association on 21-3-2018. On the last three dates of hearing, i.e., on 5-1-2018, 13-2-2018, and 14-3-2018 also the respondent Assam Cricket Association was absent without any information. Therefore, the second appeal petition dated 13-11-2017 is taken up for hearing ex-parte in the absence of the respondent.
- 2. The petitioner Sri Jyotish Kr. Das submitted orally that he has collected the necessary information and documents to substantiate that Assam Cricket Association has been substantially financed by different Govt. agencies and therefore, it should be treated as a public authority. He orally prayed for seven days' time to file his written affidavit with necessary documents in support of his contention that Assam Cricket Association is a public authority within the meaning of Section 2(h) of the RTI Act, 2005.
- 3. Time as prayed for by him is granted , fixing 1.30 P.M on 7<sup>th</sup> May, 2018 for next hearing
- 4. Issue notice to both the parties accordingly.
