**O R D E R****08-05-2018**

The review petition dt. 1-12-2017 is taken up for consideration. The ground adduced by the petitioner that the order was passed exparte without hearing him as he could not attend the hearing on 23-10-2017 due to his illness, do not appear to justify any review of the earlier order dated 23-10-2017, as the matter was disposed of in his absence, based on records.

It transpired from the written submission made by the B.D.O. Rupohihat dt. 23-10-2017 that the RTI petition dated 2-5-2017 was transferred to the Gaon Panchayat Secretaries on 29-5-2017 with copy to the applicant. The petitioner was informed by the Gaon Panchayat Secretaries jointly vide letter dt. 5-6-2017 to deposit the cost of photocopy. The petitioner filed his 1<sup>st</sup> Appeal on 10-6-2017 and was informed by the 1<sup>st</sup> Appellate authority to deposit the cost of photocopy as the letter of G.P. Secretary's was received by him on 21-6-2017 and that the 1<sup>st</sup> Appeal filed was premature, at that time. Since the petitioner was informed timely to deposit the photocopy charges for furnishing of records, the Commission directed the petitioner to deposit the photocopy charges and the public authority to furnish the document on receipt of photocopy charges.

The review petition is without any merit as the review petition has not indicated any point in the said order dt. 23-10-2017 requiring justification and hence dismissed.
