Shri Golak Chandra Deka, DYSP, Assam Police Headquarters and Shri Paresh Borah are present. A Written Statement dated 02.05.2018 has been submitted by the Assistant Inspector General of Police (A) & PIO.

The Appellant, Shri Harinarayan Pathak is present.

Perused the Written Statement. It is seen that the SPIO has merely mentioned the information provided to the Appellant through a letter dated 13.04.2017 but did not respond to the ground of grievance expressed by the Appellant in his Second Appeal dated 24.08.2017 in which he had acknowledged the receipt of the aforementioned information. It is seen that the Appellant was informed that the information sought for was held by Addl. Director General of Police, SB, Assam and therefore the same can be obtained from that authority. However, the SPIO did not transfer the RTI Application to the SB authorities. The Appellant too did not take up the matter with the said authorities.

In view of the above, the Commission hereby orders that the SPIO and DYSP, Assam Police Headquarters shall transfer the RTI Application dated 24.03.2017 to the appropriate SPIO of the SB authorities, within 6 days of receiving this order under intimation to the Appellant.

The Second Appeal is hereby disposed of. However, the Appellant shall be at liberty to move this Commission, if he is aggrieved with the response of the SPIO.
