ORDER

9.5.18

The petitioner Shri Dulal Bora is present. The Joint Secretary and SPIO Shri Naren Ch. Basumatary of Home and Political Department is also present. The second appeal petition dated 24.7.17 was taken up for hearing in presence of both the parties.

- 2. From perusal of the case records it is seen that the petitioner Shri Dulal Bora filed a complaint petition dated 10.1.15 before the Chief Secretary to the Govt. of Assam. However, the copy of the complaint petition enclosed with the second appeal petition is incomplete. So what relief or action he wanted from the complaint petition could not be made out. In any case, he followed up his complaint petition by an RTI petition dated 9.8.16 seeking the following informations:-
 - (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 10.1.15 and name of the Inquiry Officer with his designation;
 - (b) Names and addresses of the persons mentioned in the complaint petition dated 10.1.15, and
 - (c) Photo copy of inquiry report submitted by the Inquiry Officer to his higher authorities.
- 3. It is seen that name of the persons alleged against are already in his complaint petition. Therefore, no further information seems to be necessary in respect of point no. 2(b) above. Only point nos.2(a) and 2(b) above are taken for consideration.
- 4. Perusal of the incomplete complaint petition dated 10.1.15 reveals that the same or a similar matter was dealt with by this Commission earlier also and perhaps orders were also passed. The Registry of this Commission is, therefore, directed to verify, ascertain and put up, if any orders were passed by this Commission earlier on the same or similar matter filed by the same petitioner. The petitioner is also directed to furnish a complete copy of his complaint petition dated 10.1.15 and also copy of the orders and other documents that may be available with him in connection with other RTI petition that might have been filed by him earlier on the same or similar matter.
