**O R D E R**

The petitioner Shri Dulal Bora is present. The public authority is represented by Shri Prasanta Borkakati, ACS, Deputy Secretary and SPIO of Personnel Department, Govt. of Assam accompanied by Shri Ankur Sarma, Sr. Administrative Assistant of the department. The second appeal petition dated 24.7.17 is taken up for hearing in presence of both the parties.

On perusal of the case records it is seen that the petitioner filed a complaint petition dated 5.12.15 regarding selection of one Hitler Pegu by APSC for appointment as Under Secretary in the Assam Legislative Department. In his complaint petition, the petitioner complained against the then chairman, APSC, Shri Rakesh Paul and Member Shri Basanta Doley. He followed his complaint petition by RTI petition dated 9.8.16, First Appeal petition dated 16.5.17 and the second appeal petition dated 24.7.17. It is seen from the case records that the RTI petition was transferred by the office of the Chief Secretary to the Personnel Department. The SPIO of Personnel Department has submitted a written statement dated 7<sup>th</sup> May, 2018 praying for extension of time to furnish the informations sought for. However, the petitioner himself submitted that since actions against the persons complained against have already been taken up in a number of other cases of similar nature involving appointments based on irregular selection by APSC, he is no longer interested to pursue the matter. He submitted a written statement to that effect and prayed for closure of the instant second appeal. Accordingly, the matter is closed and the second appeal petition dated 24.7.2018 is disposed of.
