Both the parties are absent without any intimation. The matter is taken up for consideration based on record. The Commission vide order dated 5-4-2018 had directed the B.D.O., Barkhetri Dev. Block to show cause U/S. 21 of the RTI Act, 2005 as to why penalty should not be imposed on him for non-compliance of order dt. 12-10-2017. If for any reason he is unable to comply the order, he was directed to make a written submission stating reasons thereof before the Commission within 21 days from the date of receipt of the order.

In view of absence of both the parties it is not known whether the B.D.O., Barkhetri Dev. Block has meanwhile furnished the information to the petitioner.

The Commission therefore directs the B.D.O., Barkhetri Dev. Block to inform the Commission about action taken by him or whether he furnished the required information to the petitioner, if not already furnished, furnish the same within 30 days from the date of receipt of this order.
