<u>O R D E R</u> 21-05-2018

The petitioner Sri Chandmahammad Pradhani is present. The Executive Engineer, PHE vide letter dt. 18-5-2018 has informed that the 1st Appellate authority and the SPIO, A.E.E., PHE, Technical Branch, Belsor, PHE Division are engaged in NRC duty as Investigating Officer. Till release from NRC duty it is not be possible for the Executive Engineer and the SPIO to attend the hearing. He had stated that he has deputed one Jr. Engineer, Mr. A. Baisya on his behalf to attend the hearing, but he was not present.

In view of the fact stated above that the SPIO/AEE, PHE is engaged in NRC duty as Investigating Officer, he is directed to furnish the information sought for by the petitioner within 30 days from the date of receipt of this order. If for any reason he is unable to comply with the order, he will make a written submission to this effect, stating reasons thereof before the Commission within 30 days from the date of receipt of this order.
