<u>ORDER</u> 22-05-2018

The petitioner Sri Nava Kumar Deka is present. The Project Director, DRDA, Nalbari vide letter dt. 18-5-2018 has informed the Commission that all the staff of DRADA, Nalbari are engaged in NRC duty up to 30-6-2018 and as such the report as sought for will be submitted to Sri Nava Kumar Deka after NRC work is over.

The petitioner present admitted that he was aware that the staff was engaged in NRC work and stated he would be satisfied, if he receives the information during July, 2018 after the time bound of NRC work is over.

The Commission therefore directs the SPIO/ PD, DRDA to furnish the information sought for by the petitioner within 30-7-2018 with intimation to the Commission.
