O R D E R 25.05.2018

- 1. The petitioner Sri Atindra Das is present. The public authority to be represented by the SPIO of the office of SDM&HO Jhargaon BPHC is absent.
- 2. However, the I/c SDM&HO Jhargaon BPHC Dr. S.Deoraja has sent a written statement dated 22-5-2018, which is entered into the case records.
- 3. The written statement does not provide any information other that what his predecessor had submitted. The petitioner stated that after the last hearing on 5-2-2018 he has not received any further information from the SDM&HO of the Jhargaon BPHC in reply to his RTI petition dated 17-6-2016, nor from the office of the Joint Director, Health Services Morigaon against point No. 3 of the RTI petition which was transferred to the Joint Director by the SDM&HO vide letter dated 8-2-2018.
- 4. In the absence of the concerned public authorities this Commission could not proceed further today.
- 5. Fix 20th June,2018, 1.00 P.M for next hearing.
- 6. Issue notices to the petitioner as well as the SPIOs of the office of Joint Director, Health Services, Morigaon, Dist- Morigaon and of the office of SDM&HO, Jhargaon BPHC, Morigaon, Dist- Morigaon for their personal appearance on the next date of hearing and submisson of affidavits clarifying the actions taken by them to furnish the sought for informations to the petitioner with reference to this Commission's

earlier orders dated 5-2-2018, copy of which be enclosed along with the notices to be served to them.
