<u>O R D E R</u> 11.06.2018

1. The petitioner Sri P.Bezbaruah is absent. The public authority is represented by (i) Sri Prasanta Pratim Kathkotia, SPIO and Additional Deputy Commissioner, Kamrup (Metro), and (ii) Sri Pankaj Kr. Sarma, Deputy Registrar (Registration), Kamrup (Metro).

2. The second appeal petition dated 12-2-2018 is taken up for hearing ex parte in the absence of the petitioner. It is recorded that the petitioner has sent a written communication dated 6-6-2018 stating that due to unavoidable circumstances he is not in a position to appear before this Commission today. It is also noted that the same petitioner had filed several RTI applications earlier also and he has never attended the hearings before this Commission, leading to ex-parte disposal of his RTI applications.

3. In the present case also the appellant has requested to take necessary action as deemed fit and dispose of the second appeal petition in his absence on the basios of his written communication dated 6-6-2018. Accordingly, the second appeal petition dated 12-2-2018 is taken up for ex-parte hearing and disposal.

4. The petitioner has mentioned in his written communication dated 6-6-2018 that the First Appellate Authority heard his first appeal petition. A copy of the FFA's ex-parte order dated 16-3-2018 was enclosed with the W/S. The SPIO and Addl. Deputy Commissioner, Kamrup (Metro) apprised this Commission that in compliance with the First Appellate Authority's order , the sought for information, i.e., Process Server's report in R.A(M) case No. 9/2009-2010 and the name of the Process Server were furnished to the petitioner, vide letter No. KRC(M)-251/2015/RTI/Part-I dated 8-6-2018 a copy of which was also submitted before this Commission.

It appears that the RTI petition dated 14-6-2017 has been fully responded to.
In view of the above, the second appeal petition dated 12-2-2018 is disposed
