1. The petitioner Sri Pranjal Kr. Sarma is absent. However, he has sent a written communication dated 31-5-2018 praying for deferment of the date of hearing to any date between 15th June to 30th June..

2. The public authority , i.e., the APSC is represented by the SPIO Sri Tapan Kr. Das, SPIO of APSC accompanied by Sri Bhaba Ch. Das, Jr. Assistant of the same office..

3. The SPIO has submitted a written statement dated 1st June, 2018 stating that the petitioner has already been provided the relevant informations in response to point No. 1, 2 and 3 of his RTI petition dated 17-10-2017. Point No. 1, 2 and 3 relate to the petitioner's individual scores in screening test and viva-vocie taken by APSC for recruitment to the post of Asstt. Engineer, under PHE Department, Govt. of Assam. The screening test and viva-vocie tests were conducted by the APSC in February, 2017 and September, 2017 respectively.

4. As regards the marks obtained in the screening test and viva-vocie test by the candidates who were finally selected to the APSC for the above-mentioned post, APSC vide letter dated 15th November, 2017 informed the petitioner that the sought for information cannot be provided as per provision under Section 8(1) (d) of the RTI Act, 2005.

5. However, in the absence of the petitioner he could not be heard today. In view of the prayer of the petitioner mentioned above fix 25th June, 2018 at 1.30 P.M for next hearing.

6. Issue notices to both the parties accordingly for their attendance.
