O R D E R

26.06.2018

1. . The petitioner Prof. Srinath Baruah is present. The public authority is represented by the SPIO and Joint Secretary of Home and Political Department, Govt. of Assam Sri Naren Ch. Basumatary.

2. The second appeal petition dated 12-2-2018 is taken up for further hearing in pursuance of this Commission's earlier order dated 14-3-2018.

3. The Joint Secretary and SPIO of Political Department has submitted a written statement dated 25th June, 2018. With his written statement the SPIO has enclosed a copy of another letter No. PLA(V).28/2018/14 dated 25th June, 2018 from the Additional Secretary, Govt. of Assam, Political (Vigilance Cell) Department addressed to the Joint Secretary and SPIO of Political Department enclosing therewith the information which was directed to be furnished by this Commission's order dated 14-3-2018 – by way of letter No. PLA(V).272/2017/24 dated 27th July, 2017 from the Joint Secretary to the Govt. of Assam, Political (Vigilance Cell) Department to the Additional Director General of Police, Vigilance and Anti Corruption, Assam , Rup Nagar, Guwahati-32, whereby a request was made to initiate preliminary inquiry into the allegations made by Prof. Anupjyoti Choudhury, Registrar I/C K.K. Handique State Open University regarding some alleged financial irregularities in the University.

4. The SPIO and Joint Secretary of Political Department Sri Basumatary submitted orally that there is no other communication from the Political Department to the Directorate of Vigilance and Anti Corruption , Assam except the aforesaid letter dated 27th July, 2017.

5. In view of the above, the SPIO of Political Department is directed to furnish a copy of the said letter , dated 27th July, 2017 to the petitioner , which he did today itself before the Commission..

6. With the above order the second appeal petition dated 12-2-2018 is disposed of.
