ORDER 04.06.2018

- 1. The petitioner Sri Pranab Kr. Sarkar is absent. However, he has sent a written communication dated 1-6-2018 which is entered into the case records.
- 2. The public authority, i.e., the Principal of Nabajyoti College, Kalgachia is represented by his Advocate Sri Khayam Uddin Ahmed, accompanied by Sri Wahidur Rahman to assist him.
- 3. Dr. Shahjahan Ali Ahmed, Principal, Nabajyoti College, Kalgachia, Dist-Barpeta has submitted an affidavit dated 4th June, 2018 with enclosures. It is seen from the affidavit and the enclosures that the petitioner Sri Pranab Kr.Sarkar filed another RTI petition before the same public authority on 4-10-2017 which was heard and disposed of by State Information Commissioner Smti N.A. Hazarika by an order dated 2-2-2018. It is seen from the case records that information in respect of Dr. Md. Fakhrul Alom, Asstt.Professor of Political Science Department of the college was already furnished to the petitioner vide letter dated 25-1-2018. Informations in respect of Dr. Shahjahan Ali, were also furnished to the petitioner vide letter dated 25-1-2018. In pursuance of SIC Smti N.A.Hazarika's order dated 2-2-2018 the remaining informations in respect of Dr. Fakhrul Alom were also furnished to the petitioner vide letter dated 5-3-20-18.
- 4. From the above it appears that point No. 1,2 and 3 of the RTI petition dated 23-11-2017 have been satisfactorily responded to.
- As regards point No. 4 of the RTI petition, i.e., details of appointment of teachers in Nabajyoti college, Kalgachia the petitioner was informed vide letter dated 25-1-2018 that no permanent teacher was appointed during the tenure of Md.Muzammel Hussain i/c Principal. This reply does not indicate whether any temporary or adhoc teachers were appointed. The SPIO and Principal of Nabajyoti college, Kalgachia is directed to inform the petitioner within 30 days from the date of receipt of this order the names, educational

qualifications and other particulars with reference to eligibility criteria for appointment to the post of teachers in the college, if any temporary/adhoc teachers were appointed in the college during the tenure of Md. Muzammel Hussain, Principal i/c of the college along with copies of relevant Governing Body resolutions.

6. With the above order the second appeal petition dated 21-3-2018 is disposed of with the observation that the petitioner should refrain from filing repeatitiveed RTI petitions or RTI petitions with slight modifications on the same subject before the same public authority or other related public authorities as they amount to avoidable addition to the workload of the concerned public authorities and appellate authorities,
