**O R D E R**  
**06.06.2018**

1. The petitioner Sri Purnananda Chamua is present. The public authority is represented by Smti Lalita Devi, Joint Director and SPIO of the Commissionerate of Panchayat and Rural Development, accompanied by Md. A.B.H Bahar Barbhuiya , Sr.Assistant of the same office.
2. The second appeal petition dated 6-4-2018 read with RTI petition dated 9-1-2018 is taken up for hearing in presence of both the parties.
3. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 9-1-2018 before the Commissioner of Panchayat and Rural Development, seeking several informations about the selection test held in the year 2014 for recruitment to the post of Village Level Worker (Gram Sevaks).
4. Not getting any information in response to his RTI petition and subsequent first appeal petition dated 27-2-2018 the petitioner Sri Chamua filed his second appeal petition dated 6-4-2018 before this Commission.
5. The Joint Director and SPIO of the Commissionerate of Panchayat and Rural Development,(CPRD) Govt. of Assam has submitted a written statement dated 2<sup>nd</sup> July, 2018 enclosing a copy of their letter dated 25<sup>th</sup> May, 2018 addressed to the petitioner Sri P.Chamua furnishing him the available sought for informations. It has been mentioned in the W/S that a copy of the RTI petition was transferred to the Managing Director of AMTRON for furnishing a copy of the answer script of the petitioner bearing Roll No. 45216. A copy of the Joint Director, CPRD's letter dated 25<sup>th</sup> May, 2018 addressed to the Managing Director, Assam Electronics Development Corporation (AMTRON) Ltd. in this regard with a copy to the petitioner was also enclosed with the W/S.

6. The petitioner submitted that he has not yet received the SPIO's letter dated 25<sup>th</sup> May, 2018 furnishing him the informations and copy of SPIO's letter of the same date to the Managing Director, Assam Electronics Development Corporation, Ltd (AMTRON).

7. On direction from this Commission, the SPIO of CPRD provided copies of both the documents to the petitioner today in presence of this Commission.

8. In view of the above, the second appeal petition dated 6-4-2018 is disposed of.
