O R D E R

1. The petitioner Sri Utpal Das is present. The public authority is represented by Smti Alin Begum, Executive Engineer, Planning Branch of Guwahati Municipal Corporation (GMC) accompanied by Sri Jitu Ballav Dutta, U.D. Assistant of GMC.
2. The Executive Engineer of GMC Smti Alin Begum submitted that the petitioner is yet to furnish the information he was required to provide vide Assam Information Commission's order dated 20-11-2017 in respect of point No. 1-3 of the RTI petition. The petitioner Sri Utpal Das submitted that he will personally go and meet the Executive Engineer, GMC and provide her the names of the owners in whose names the building permissions were granted. The Executive Engineer assured that on receipt of those information she will be able to furnish the sought for informations in respect of point No. 1 & 3. The petitioner and the Executive Engineer, GMC are directed to complete this process within 30 days from the date of receipt of this order.
3. Coming to point No. 2 of the RTI petition also the petitioner stated that he will go for inspection of necessary office records when he meets the Executive Engineer, GMC with regard to point Nos. 1 & 3.
4. The petitioner as well as the Executive Engineer, GMC are directed to complete the inspection of records within the aforesaid period of 30 days.
5. With the above order, the second appeal petition dated 29-8-2017 is disposed of.
