**O R D E R**  
**08.06.2018**

1. . The petitioner Sri Dulal Bora is present. The Staff Officer and SPIO to Chief Secretary, Govt. of Assam is absent. However, she has sent a written communication dated 08-6-2018 stating that she had to accompany the Chief Secretary to Nalbari on official duty. She has authorized Sri Pancham Pawe , Senior Administrative Assistant of Chief Secretary's office to attend today's hearing on her behalf.
2. The appellant Sri Dulal Bora submitted orally that in compliance with this Commission's order dated 27-4-2018 at paragraph 7 (seven) he had already furnished a copy of the relevant document to the SPIO of Political Department. He assured that he will furnish a copy of the same to the Registry of this Commission.
3. The staff officer and SPIO of the office of Chief Secretary, Govt. of Assam submitted a written statement dated 17<sup>th</sup> May, 2018 enclosing an explanatory letter dated 17-3-2018 from Sri Pancham Pawe, Sr. Administrative Assistant of the office of Chief Secretary, who deals with RTI matters in the Chief Secretary's office. Sri Pawe submitted that he would like to verify the office records once again and sought some time for the same.
4. Time as prayed for is granted. Both Sri Pawe, Sr. Administrative Assistant (to make further submissions , if any, through the SPIO of Chief Secretary's office.
5. *Issue notices to (a) both the parties accordingly. (b) SPIO and Deputy Secretary, Political Department, to inform this Commission whether he has received the sought for documents from Sri Dulal Bora , and also to be present on the next date of hearing.*
