ORDER 19.06.2018

- 1. The petitioner Sri Nitumani Choudhury is present. The public authority to be represented by the SPIO of the office of Superintendent of Police, Mangaldoi is absent without any information.
- 2. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 22-12-2017 before the Superintendent of Police, Mangaldoi seeking several informations with reference to case No. 704/17 of Mangaldoi P.S. The sought for informations/ documents are :-
 - (i) Extract copy of General Diary Entry of Mangaldoi P.S and Enquiry Report in connection with the said case No.
 - (ii) Injury/ Death person list.
 - (iii) MVI report
 - (iv) Seizure list
 - (v) Inquiry report
 - (vi) P.M report if any
 - (vii) Skectch map
 - (viii) Photocopy of vehicular documents.
- 3. Not getting any information even after filing of first appeal petition dated 5-12-2018 the petitioner has now come up before this Commission with his second appeal petition dated 21-3-2018.
- 4. From perusal of the case records it appears that the sought for informations are required in connection with a motor vehicle accident case. The petitioner submitted that he works as an Investigator for an Insurance Co. He further

submitted that he approached the concerned police station for the sought for documents which are required for settling a motor vehicle accident insurance claim, but he was not given those documents. As a result the Insurance Company has not been able to settle the motor vehicle claim made by the claimant for nearly two years.

5. In the absence of the SPIO of the office of Superintendent of Police, Mangaldoi he could not be heard.

6. This Commission is of the view that, prima facie, the documents sought for by the petitioner are admissible under the RTI Act,2005. In the absence of any representative from the office of Superintendent of Police, Mangaldoi, District- Darrang, it could not be ascertained whether the sought for documents are also covered under the Assam Right to Public Service Act, 2012 requiring payment of certain prescribed fees to obtain them, or whether the concerned police officials are not providing those documents on the ground of any of the exemptions provided under Section 8(1)) of the RTI Act, 2005.

7. The SPIO of the office of Superintendent of Police, Mangaldoi is, therefore, directed to submit a written statement within 20 days from the date of receipt of this order clarifying the reasons/ grounds of which the sought for informations have not been provided to the petitioner so far.

8. The SPIO of the office of Director General of Police, Assam is also directed, in exercise of powers under Section 19(8) of the RTI Act, 2005 to submit a separate written statement within 20 days from the date of receipt of this order whether the State Police Headquarters has issued any instructions and or guidelines to the SPs of different districts and to the O.Cs of Police Stations under them in the matter of furnishing copies of documents required for settlement of Motor Vehicle accident claims.

9. Issue notices to the SPIOs of (i) Director General of Police, Assam, (ii) SPIO of Mangaldoi, Assam and , (iii) the petitioner for their presence on the next date of hearing.

10. Fix 31-7-2018 at 1.00 P.M for review of action taken.
