1. The appellant / petitioner Sri Dulal Bora is absent. He has sent a written submission dated 10th May, 2018 praying for deferment of the date of hearing as he is unable to attend the Commission today due to other engagements.
2. The SPIO of the office of Chief Secretary has sent a written statement dated 19th April, 2018 stating that the original complaint petition dated 5-3-2016 containing some complaints against one Sri Kumud Kalita, the then Director of Social Welfare Department was transferred to the Principal Secretary, Personnel Department on 8-3-2016 vide Dy. No. 485.
3. The subsequent RTI petition dated 30-7-2016 as well as the first appeal petition dated 16-5-2017 were also transferred to the SPIO of Personnel Department vide letters dated 4-8-2016 and 2-6-2017 respectively. The W/S is entered into the case records.
4. From perusal of the case records, it is seen that the petitioner Sri Dulal Bora was absent on the last date of hearing, i.e 18-4-2018 also and sought deferment on health grounds. Today also he has sought deferment on grounds of other engagements.
5. His prayer is granted with the rider that no further deferment will be allowed and the second appeal petition dated 24-7-2017 will be taken up for hearing and disposal ex-parte in the event of his absence on the next date of hearing also.
