O R D E R
10.05.2018

1. . The appellant / petitioner Sri Dulal Bora is present. The public authority, is represented by Smti Malita Barman. ASPIO, Deputy Secretary to the Govt. of Assam, Social Welfare Department, Dispur, Guwahati-6.

2. The second appeal petition dated 24-7-2017 read with the RTI petition dated 9-8-2016 and first appeal petition dated 16-5-2017 is taken up for hearing in presence of both the parties.

3. From perusal of the case records it is seen that the petitioner Sri Dulal Bora filed a complaint petition dated 22-5-2015 before the Chief Secretary to the Govt. of Assam alleging misappropriation of fund of the Directorate of Social Welfare by an organization called MLTC- Sadou Asom Grammya Puthibharal Santha, Haiboirgaon, Nagaon in the name of job training of Supervisors.

4. The petitioner followed up his complaint petition by an RTI petition dated 9-8-2016 by which he sought the following informations:-

- (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 22-5-2015 and name of the Inquiry Officer with his designation ;
- (b) names and addresses of the persons mentioned in the complaint petition dated 22-5-2015, and
- (c) photocopy of inquiry report submitted by the Inquiry Officer to his higher authorities.

5. The name and address of the accused persons/ organization are mentioned in the complaint petition. Therefore, no further information on this point seems to be necessary. Hence, only points 4 (a) and 4 (c) above are taken up for consideration.

6. The SPIO and Deputy Secretary of Social Welfare Department has submitted a written statement dated 8-5-2018 which is entered into the case records.

7. It has been mentioned in her W/S that after receipt of the complaint petition it was forwarded to the Directorate of Social Welfare, Govt. of Assam, which was followed by a detailed inquiry conducted by the District Social Welfare Officer, Nagaon. A copy of her letter dated 8th May, 2018 addressed to Sri Dulal Bora furnishing the above information was enclosed with the W/S. A copy of the inquiry report which the DSWO, Nagaon conducted and submitted to the Directorate of Social Welfare was not, however, furnished to the petitioner.

8. The SPIO of Social Welfare Department is, therefore, directed to furnish a copy of the inquiry report, free of cost, to the petitioner within 15 days from the date of receipt of this order.

9. With the above order the second appeal petition dated 24-7-2017 is disposed of.
