O R D E R
21.05.2018

1. The petitioner Sri Hara Kanta Bora is present. The public authority is represented by (i) Mrs. B.G. Bhuyan, AES, District Elementary Education Officer, Kamrup(Metro), (ii) Mr. Sanjay Dey, Junior Administrative Assistant of the same office, (iii) Sri Sidharrtha Gogoi, S.I of Schools of the office of Deputy Inspector of Schools, (iv) Sri Abdul Gafar Ahmed, Head Master, Lokabandhu Nagar L.P. School, Kahilipara and (v) Sri Amrit Saikia, SMC, President, Lokabandhu Nagar L.P. School, Kahilipara.

2. The second appeal petition dated 11-2-2018 filed by the petitioner Sri Hara Kanta Bora read with his RTI petition dated 28-10-2017 and First Appeal petition dated 28-12-2017, is taken up for hearing in presence of both the parties.

3. From perusal of the case records it is seen that the petitioner Sri Hara Kanta Bora filed his RTI petition dated 28-10-2017 before the SPIO of the office of District Elementary Education Officer, Kamrup District. The informations sought for by him were :-

- (i) Copy of the spot enquiry report conducted by the DEEO, Kamrup (M) in response to the letter No. DEE/RTI/120/2017/10 dated 28-07-2017 of the State Public Information Officer and Dy. Director, Elementary Education, Assam, Guwahati-19
- (ii) Written statement so taken from the Headmaster as well as from other teachers from the school
- (ii) Reports submitted by the Managing Committee of the school in this regard
- (iii) Steps so taken to free from encroachment of North West corner of the school's land.

4. The petitioner submitted today copies of letter dated 28-7-2017 written by the Deputy Director, Elementary Education to the District Elementary Education Officer, Kamrup

(Metro) together with his complaint letter dated 20-7-2017 addressed to the SPIO of the Directorate of Elementary Education, Assam, together with a sketch of the site of Lokabandhu Nagar Primary School premises prepared by the petitioner himself.

4. The Director, Elementary Education, Govt. of Assam has sent a written submission dated 18th May, 2018 stating that the petitioner filed RTI petition dated 2-6-2017 on the same matter earlier also. The District Elementary Education Officer, Kamrup (Metro) furnished the available informations to the petitioner on 14-7-2017. Thereafter, the petitioner filed appeal petition dated 20-7-2017, whereafter the DEEO, Kamrup (Metro) was requested to conduct a spot inquiry into the matter and submit the inquiry report at an early date.

5. The DEEO, Kamrup (Metro) has also submitted a separate written statement dated 19-5-2018 which is also entered into the case records.

6. The DEEO Kamrup (Metro) also submitted copy of a letter dated 8-9-2017 requesting the Deputy Inspector of Schools, Guwahati to conduct a spot inquiry as directed by the Deputy Director, Elementary Education vide his letter dated 28-7-2017. The DEEO submitted orally that she is yet to receive the spot inquiry report from the D.I of Schools, Kamrup (Metro).

7. In view of the above the D.I of Schools, Kamrup (Metro) is directed to conduct the spot inquiry and complete the same within 10 days from the date of receipt of this order which was pronounced in his presence.

8. The DEEO is directed to furnish to the petitioner a copy of the report of the spot inquiry along with other informations sought for by the petitioner vide his RTI petition dated 28-10-2017 within another 10 days from the date of receipt of the spot inquiry report from the D.I of Schools, Kamrup (M)

9. With the above order the second appeal petition dated 11-2-2018 is disposed of.
