#### ORDER 11.05.2018

- 1. The appellant / petitioner Sri Dulal Bora is absent. He has sent a written submission dated 10<sup>th</sup> May, 2018 praying for deferment of the date of hearing as he is unable to attend the Commission today due to other engagements. The Home Department was represented by Sri P.C. Deka, Superintendent, Home 'A' Department as authorized by the Joint Secretary and SPIO of the Department vide letter dated 10th May 2018 which is entered into the case records.
- 2. The SPIO of the office of Chief Secretary has sent a written statement dated 20<sup>th</sup> April, 2018 stating that the petitioner's original complaint petition dated 5-3-2016 containing some allegations against one Sri Sanjib Saikia, Additional Superintendent of Police (Headquarter) working under the Police Commissionerate, Guwahati was transferred to the Additional Chief Secretary, Home Department on 8-3-2015 vide Dy. No. 491. She mentioned in the W/S that subsequent RTI petition dated 30-7-2016 and first appeal petition dated 16-5-2017 were also transferred to the SPO of Home and Political Department vide letters dated 4-8-2016 and 26-5-2017 respectively.
- 3. It is seen from the case records that the petitioner Sri Dulal Bora was absent on the last date of hearing, i.e 18-4-2018 also and sought deferment on health grounds. Today also he has sought deferment on grounds of other engagements.
- 4. His prayer is granted with the rider that no further deferment will be allowed and the second appeal petition dated 24-7-2017 will be taken up for hearing and disposal ex-parte in the event of his absence on the next date of hearing also.
- 5. Fix <u>24-5-2018</u>, <u>1.00 P.M</u> for next hearing.
