ORDER 10.05.2018

- 1. The appellant / petitioner Sri Dulal Bora is present. The public authority, i.e, the Assam Legislative Assembly Secretariat is represented by Sri Pradip Handiqui, Deputy Secretary and SPIO and Sri Samir Das, Under Secretary and APIO of the same office.
- 2. The second appeal petition dated 24-7-2017 read with the RTI petition dated 30-7-2016 and the first appeal petition dated 16-5-2017 is taken up for hearing in presence of both the parties.
- 3. From perusal of the case records it is seen that the petitioner Sri Dulal Bora filed a complaint petition dated 31-5-2016 addressed to the Chief Secretary to the Govt. of Assam against appointment of one Smti Jinti Das, alleging that her appointment was irregular, and by his petition dated 31-5-2016 the petitioner requested the Chief Secretary to inquire into the matter. He followed up his complaint petition by an RTI petition, first appeal petition and second appeal petition mentioned above.
- 4. The SPIO of the office of the Chief Secretary has submitted a written statement dated 5-5-2018 stating that the RTI petition and the first appeal petition were transferred to the Principal Secretary, Assam Legislative Assembly. Her written statement is entered into the case records.
- 5. The PIO of ALA has submitted a separate written statement dated 9-5-2018 which is also entered into the case records. In his W/S the PIO has mentioned that vide letter dated 5-9-2016 the petitioner was already furnished the informations sought for by him.
- 6. By his RTI petition dated 30-7-2016 it is noted that the petitioner sought the following informations:-

- (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 31-5-2016 and name of the Inquiry Officer with his designation;
- (b) names and addresses of the persons mentioned in the complaint petition dated 31-5-2016, and
- (c) photocopy of inquiry report submitted by the Inquiry Officer to his higher authorities.
- 7, The petitioner was informed vide letter dated 5-9-2016 that no informations exist against the first and the third query of his RTI petition, which means that no inquiry was ordered and there is no inquiry report copy of which can be furnished to the petitioner.
- 8. As against the second query the petitioner was informed that the names of the person complained against was already mentioned in his RTI petition. Therefore, it was not furnished.
- 9 From the above, it is seen that the RTI petition has been substantially responded to by the ALA Secretariat. There seems to be no further cause of action on the RTI petition so far as this Commission is concerned.
- For further grievance, if any, the petitioner will be at liberty to approach the concerned competent authority.
- 11, With the above order the second appeal petition dated 24-7-2017 is disposed of.
