O R D E R 28.05.2018

- 1. The petitioner Sri Dulal Bora is present. The public authority is represented by Sri Niranjan Bora, ACS, Under Secretary and SPIO of Chief Minister's Secretariat accompanied by Sri Prabal Jyoti Medhi, Sr.Administrative Assistant of the C.M's Secretariat.
- 2. The second appeal petition dated 27-6-2017 is taken up for hearing in presence of both the parties.
- 3. From perusal of the case records it is seen that the petitioner filed a complaint petition dated 19-11-2014 before the Principal Secretary to Chief Minister, Assam alleging commission of financial irregularities committed by the then Minister, Social Welfare Sri Akon Bora.
- 4. He followed up his complaint petition by an RTI petition dated 31-8-2016 seeking the following informations:-
 - (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 19-11-2014 and name of the Inquiry Officer with his designation;
 - (b) names and addresses of the persons mentioned in the complaint petition dated 19-11-2014, and
 - (c) photo copy of inquiry report submitted by the Inquiry Officer to his higher authorities.
- 5. Thereafter the petitioner filed a first appeal petition dated 22-5-2017 followed by the instant second appeal petition dated 27-6-2017.

- The SPIO of Chief Minister's Secretariat submitted a written statement dated 25-5-2018 stating that the RTI petition dated 31-8-2016 along with the complaint petition dated 19-11-2014 have been transferred to the SPIO of Home Department vide letter dated 24-5-2018 i.e., yesterday.
- 7. The petitioner submitted that he has meanwhile received the sought for information from the Director, Vigilance and Anti Corruption in response to another RTI application which he filed before them. He submitted orally that as per information furnished by the Director, Vigilance and Anti Corruption they are conducting regular inquiry into the allegations made by the petitioner.
- 8. In view of the above, the petitioner has submitted a written statement dated 25th May, 2018 requesting to allow him to withdraw the second appeal petition.
- 9. His prayer is granted and the second appeal petition dated 27-6-2017 is accordingly disposed of.
