**O R D E R**  
**14.06.2018**

1. The petitioner Sri Pranab Kr. Sarkar is absent. However, he has submitted a written communication dated 13<sup>th</sup> June, 2018 stating that he has not received any information from the concerned SPIO with reference to his RTI petition dated 2-4-2018 and requested for giving a direction to the concerned official to furnish the information sought for by him.
2. The concerned SPIO of Assam Higher Secondary Education Council is absent without any information. The appeal petition dated 7-5-2018 is taken up for consideration ex-parte.
3. It is seen from the case records that the petitioner Sri Pranab Kr. Sarkar filed an RTI petition dated 2-4-2018 before the SPIO of Assam Higher Secondary Education Council regarding issuance of original Higher Secondary Education Council pass certificate of the petitioner with Roll-639 No. A-181, year 1994, Bijni College, Bijni.
4. The Deputy Secretary (Inspection) of Assam Higher Secondary Education Council by his letter dated 8-6-2018 has meanwhile informed the Registry of this Commission that the pass certificate in respect of the petitioner Sri Pranab Kr. Sarkar bearing Roll 639 No-A-181 who had passed the Higher Secondary Education Council final examination from Bijni College in the year 1994 was dispatched on 15-5-2018 by Registered Post vide No. RS484264875IN.
5. In the absence of the petitioner it could not be ascertained whether he has since received his Higher Secondary Pass certificate .

6. In view of Assam Higher Secondary Education Council's letter dated 8-6-2018 mentioned above, the petitioner is directed to directly contact the Council or the postal authorities if he is yet to receive the said certificate.

7. With the above order the second appeal petition dated 7-5-2018 is disposed of.
