**O R D E R**  
**18.06.2018**

1. The public authority is represented by Sri Naren Ch. Basumatary, Joint Secretary and SPIO of Home and Political Department and Smti Kirti Jalli, SPIO and Staff Officer of the office of Chief Secretary, Assam. The petitioner Sri Dulal Bora is absent. However, vide an e-mail dated 18<sup>th</sup> June, 2018 he has prayed for re-fixation of the date of hearing as he is out of station today.
2. The SPIO of the office of Chief Secretary has submitted a written statement dated 25<sup>th</sup> May, 2018 stating that the petitioner's original complaint petition dated 26-9-2015 addressed to the Chief Secretary, Govt. of Assam containing complaints against Sri Nilomoni Sen Deka, former Agriculture Minister, Assam and his son was transferred to the Commissioner & Secretary, Home and Political Department on 29-9-2015.
3. The Joint Secretary and SPIO, Political Department has submitted a separate written statement dated 15<sup>th</sup> June, 2018 with a copy to the petitioner Sri Dulal Bora. A copy of the Additional Secretary, Govt. of Assam, Political (Vigilance Cell) Department letter dated 15<sup>th</sup> June, 2018 was enclosed with the written statement. The Additional Secretary of Political (Vigilance Cell) Department vide letter No. PLA(V) 318/2015/3 dated 22-2-2018 stated in the aforesaid letter that the ADGP, CID, Assam was requested for taking necessary action on the allegation petition dated 26-9-2015 submitted by Sri Dulal Bora.
4. The above reply appears to be adequately responsive to the RTI petition dated 9-8-2016. Hence the second appeal petition dated 24-7-2017 is disposed of.
